#### **LEGAL RELEASE**

By participating in the Hyde Park Pet Parade (the "Event"), I, the undersigned participant, acknowledge and agree to the following terms and conditions. This legal release ("Release") is entered into between the participant ("Participant") and the organizers of the Event ("Organizers").

# Assumption of Risk:

I acknowledge that participating in the Event involves certain inherent risks, including but not limited to, the risks associated with pets, animals, and public gatherings. I voluntarily assume all risks and hazards associated with the Event, including, but not limited to, injury, illness, property damage, or any other harm that may arise from participating in the Event.

## Pet Responsibility:

I warrant and represent that any pet I bring to the Event shall be pet-friendly, well-behaved, and under my control at all times. I understand that any aggressive or disruptive behavior displayed by my pet may result in my immediate removal from the Event premises.

#### Vaccination and Health:

I confirm that all pets I bring to the Event are up to date on their vaccinations as required by applicable local and state laws. I understand that it is my responsibility to ensure that my pets are in good health and free from any contagious diseases. The Organizers reserve the right to request proof of vaccination or refuse entry to any pet that poses a health risk.

## Release of Liability:

To the fullest extent permitted by law, I hereby release, waive, discharge, and covenant not to sue the Organizers, their officers, directors, employees, volunteers, and agents (collectively referred to as the "Released Parties") from any and all liability, claims, demands, actions, or causes of action arising out of or relating to any loss, damage, injury, illness, or harm to myself, my pet, or any third party, whether caused by the negligence of the Released Parties or otherwise.

#### Media Release:

I grant the Organizers the irrevocable right and permission to use photographs, videos, or other media taken during the Event, which may include images of myself and my pet, for promotional, advertising, or any other lawful purposes without any compensation to me.

# Severability:

If any provision of this Release is held to be invalid, illegal, or unenforceable, the validity, legality, and enforceability of the remaining provisions shall not be affected or impaired.

# Governing Law and Jurisdiction:
